What does happen with the data? The organization from your country can send you the maximum of two emails to inform you about this campaign and the organization itself.

What is a cookie?

A cookie is a small text file that is placed on your computer, tablet, or smartphone during your visit to a website. This file stores information that is recognized during subsequent visits. This makes it possible, for example, to stay logged in on a website or to remember your language settings.

There are three types of cookies:

Functional cookies: these are cookies that are necessary for the website to function. Think of a webshop where the products you place in your shopping cart are remembered.

Analytical cookies: these cookies collect statistics, such as the number of visitors to the website and the click behavior of visitors.

Tracking cookies: by placing these cookies, it is possible to track your behavior online. For example, after viewing a particular product on a webshop, you may see this product again in an advertisement on another website.

Cookies on this website

VluchtelingenWerk Nederland uses functional, analytical, and tracking cookies. The functional cookies are used, among other things, for the integration of social media on our website, such as Twitter and Facebook. We use analytical cookies to improve the quality of our website. By looking at how visitors use our website and which links are clicked the most, we can determine which parts of our website are the most interesting to our visitors.

We also use cookies to see if a page that we think is interesting for you is also easily found. For example, if you are looking for certain information on our website but cannot find it, we can see that in the statistics collected by the cookies. This way, we know how to make the structure, navigation, and content of our website more user-friendly.

The cookies we use for advertising via Google Adwords shows us the demographic data of the Adwords visitors, but this data cannot be traced back to an individual person. We use a so-called "Third party cookie" for this purpose. You can read more about these cookies [here](#).

Finally, our Facebook tracking cookie keeps track of how often promotional content is viewed and gives us insights into the advertising campaign on Facebook. This prevents you from seeing the same advertisement too often. Advertisers and third parties can use these tracking cookies to create a visitor profile. How to delete cookies?

It is possible to delete cookies. How to do this depends on the web browser you use to view web pages. Popular web browsers include Internet Explorer, Google Chrome, Mozilla Firefox, and Safari. You can also set your browser to receive a notification when you receive a cookie or to block cookies. This may cause the website to

function less optimally. For more information on settings related to cookies and specific browsers, it is best to consult the help function of your web browser.
